



**ANNUAL MEMBERS' FORUM AND BUSINESS MEETING
MINUTES
November 4, 2022**

CALL TO ORDER

With proper notice given and a quorum of over 50 members present, Dr. Laurie DeLeve, AASLD President, called the 73rd Annual Members' Forum and Business Meeting to order on November 4, 2022 at 1:00 PM ET.

Dr. DeLeve presented a report of the major accomplishments achieved in 2022.

Affirmation of Leadership Election

2023 COMMITTEE APPOINTMENTS

Dr. Chung reported that 313 standing committee positions will exist in 2021. The membership nominated 470 individuals to fill 110 open positions for 2023 service, 55% of those appointed will be serving on a committee for the first time and 52% are females and 27% of Appointees are Black or African American, Hispanic or Latino, or biracial.

SECRETARY'S REPORT

Approval of Minutes

The minutes of the previous meeting held virtually on December 7, 2021 were approved by an online vote by the membership in October 2022.

Membership Report

As of June 30, which marks the end of our fiscal year, AASLD's membership was seven (7%) percent above the association's total in June 2021. Our new members increased 20% above last year's total. AASLD ended the 2021-2022 membership year on June 30, 2022, with 6,730 active members – this is 458 members (7%) above our total members as of June 30, 2021.

AASLD welcomed 1102 new members this year, which is a 20% increase (+181 members) above last year's total (921).

REPORT OF THE TREASURER

Dr. Vijay Shah reported that AASLD and the AASLD Foundation Financial Statements for FY2022 (July 1, 2021 to June 30, 2022) were audited. The Finance Committee, which oversees the financial and investment activities of AASLD, reviewed the independent auditor's reports by GRF CPAs & Advisors.

The Governing Board reviewed and approved the FY2022 audit reports on October 20, 2022. The auditors reported that the financial positions for AASLD and the AASLD Foundation were strong and rendered an unmodified (clean) opinion regarding the finances and internal control procedures, the best audit report opinion any organization can receive.

Dr. Shah reviewed highlights from FY22, including consolidated statements of financial activities. The FY23 approved combined budget was also presented.

AASLD FOUNDATION

Dr. Bruce Luxon reported that the Foundation funded over \$1.5 million in funding towards awards and education. The Research & Career Development award recipients, selected from a highly competitive applicant pool, demonstrated both exceptional aptitude and deep interest in liver disease research and treatment.

Dr. Luxon also presented major accomplishments within the four major strategic pillars of Member Engagement; Accelerating Progress; Mission Investment; and Patient Engagement.

Dr. Luxon also presented results from the Liver Leading Challenge, a focused fundraising campaign.
